The undersigned agrees to the City of McVile, North Dakota, to pay all charges for utilities used and services rendered on the said described premises, in accordance with the amounts shown by the water meter and at the time specified in the water bills as rendered, in consideration of the connection to the water supply system of the City of McVile and of supplying of water, waste collection, and sewer services for the premises described. The undersigned is responsible for all utilities and agrees to abide by all provisions, conditions, requirements, and regulations as outlined in the ordinances of the City of McVile regarding utility service and collection, as such ordinances now exist and as from time to time are amended. Disconnection is possible if payment becomes 30-day delinquent. By signing below you are in agreement with these terms and conditions.

The undersigned agrees to pay as a resident of the City of McVile all services provided as described above as to incur responsibility of infrastructure development of the city. More specifically agree to pay minimum fees for water, sewer, pest control and garbage on a monthly basis for as long as they occupy such premises.

The undersigned further agrees that this agreement shall remain in effect and shall be binding until termination of services and the undersigned agrees to pay for all services until the final reading of water meter.

The undersigned further agrees to provide payment of a \$125.00 deposit for city services at the time of this application and a water hookup fee of \$50.00. If bill is kept current for 18 consecutive months, deposit is to be refunded to the account.

The undersigned acknowledges that the meter could be damaged if precautions are not taken to protect it from North Dakota's extreme weather conditions, especially cold. The undersigned agrees to be financially responsible for damage to the meter if measures are not taken to protect the meter while it is in the residence. The City of McVile reserves the right to enter the above-described property to retrieve such meter if terms of this agreement are not kept, the utility charges become delinquent, and/or the property appears to be abandoned. The undersigned hereby agrees to allow the City of

McVille access to the property to remove the meter under the above conditions. A Nelson County Sheriff's Department representative may accompany the City of McVille public works employee to remove the same.
